OR

Exceptions for DL101 may be given for those

- who have completed subject on IPR during their Studies OR
- who have completed any course on IPR from RGNIPM Nagpur and must upload evidence/certificate for the same from Institute (while applying online)

- Motivation letter for Summer School (reason for applying & what is expected to be gained from the Summer School - Maximum 300 words)
