OR	Online joint webinar/workshop on various topics of IPR (around <b>Half day</b> )	Rs 10000 (upto 100 participants thereafter 100 Rs per participants) certificate will be given to participants, subject to submission of details of participants who have attended the programme
As per requirement of RGNIIPM	Online joint webinars for one day on various topics of IPR ( <b>One Day</b> )	Rs 25000 (upto 50 participants thereafter 500 Rs per participants) certificate will be given to participants, institute/organization, subject to submission of details of participants who attended the programme

**Deliverables for Host organization for joint programme:-**

The host organization Director/Principal/Head can give proposal for program on letterhead to RGNIIPM with suitable 2 dates  
The host organization shall provide all the online facilities required and give the link for non-paid programme

**Covenants of RGNIIPM for joint programme:-**

The date of programme will be decided by RGNIIPM. One or Two speakers will be from RGNIIPM / IPO/ Guest speaker,  
The course content of programme will be prepared by RGNIIPM,  
RGNIIPM & the host organization will provide joint certificate to the participants for half /one day workshop which will be printed by RGNIIPM on standard format as decided by RGNIIPM,  
RGNIIPM reserves rights to accept or reject the request of organizations without any reasons.
